Five years after 9/11, we question whether or not terrorist activity has actually decreased. Terrorist networks still span the globe and, some argue, they are more powerful than ever. By allowing politics to trump the need for trans-national cooperation, the authors contend, the international community—and particularly the United States—has squandered an opportunity to combat terrorism with a united and powerful force. Thus what should have been a watershed moment in international relations vanished as effective long-term policies were shunned in favor of short-term political expediency. From arguing the Iraq War has been a “strategic defeat” to

Afghanistan's struggle against the Taliban to the rapidly growing geopolitical role of Iran, *Countering Terrorism* investigates the reality of the changes that followed the bombings and attacks and examines global terrorism from every angle, including the social and economic underpinnings of terror networks. Scholars, experts, and citizens have appealed for a re-evaluation of today's increasingly ineffective "War on Terror" policies, and Chandler and Gunaratna answer this call with clear and concise proposals for future dealings with global terrorism. The projected end results of the wars, terrorist attacks, and political upheavals tearing nations apart today are rarely anything but bleak. But *Countering Terrorism* challenges today's chaotic status quo, offering penetrating analysis and a radically new perspective essential to grappling with the complexities of terrorist activity and counterintelligence today. ### **Amagansett**

On Palm Sunday 1964, at the Second Presbyterian Church in Memphis, a group of black and white students began a "kneel-in" to protest the church's policy of segregation, a protest that would continue in one form or another for more than a year and eventually force the church to open its doors to black worshippers. In *The Last Segregated Hour*, Stephen Haynes tells the story of this dramatic yet little studied tactic which was the strategy of choice for bringing attention to segregationist policies in Southern churches. "Kneel-ins" involved surprise visits to targeted churches, usually during Easter season, and often resulted in physical standoffs with resistant church people. The spectacle of kneeling worshippers barred from entering churches made for a powerful image that invited both local and national media attention. The Memphis kneel-ins of 1964-65 were unique in that the protesters included white students from the local Presbyterian college

(Southwestern, now Rhodes). And because the protesting students presented themselves in groups that were "mixed" by race and gender, white church members saw the visitations as a hostile provocation and responded with unprecedented efforts to end them. But when Church officials pressured Southwestern president Peyton Rhodes to "call off" his students or risk financial reprisals, he responded that "Southwestern is not for sale." Drawing on a wide range of sources, including extensive interviews with the students who led the kneel-ins, Haynes tells an inspiring story that will appeal not only to scholars of religion and history, but also to pastors and church people concerned about fostering racially diverse congregations.

On November 17, 1964, a new and rather unique political organization was inaugurated in Japan. This organization was called Komeito or the Clean Government Party. ! The mother organization was the lay Buddhist group, Soka Gakkai or Value Creation Society. It had previously been engaged in some political activities, but the establishment of the party was an indication of serious intent to become even more involved in Japanese political affairs. The rather militant posture of Soka Gakkai and its phenomenal success in converting literally millions of Japanese to the Nichiren Buddhist religion was somewhat disconcerting for observers, both Japanese and foreign. Because of its political activism, many persons viewed the organization as similar to the pre-World War II ultra-nationalist movement, while others applauded Soka Gakkai for giving new life and hope to a large segment of Japanese society that was only receiving a marginal share of Japan's increasing prosperity. Any mass movement may appear rather ominous to some people and a rapidly expanding and aggressive movement is bound to be perceived as a threat to society. Soka Gakkai is no exception, and therefore has been the subject of much debate and controversy in both Japan and abroad. As is often the case with controversial matters, a new perspective will help to clarify some of the more contentious issues of this movement.

## Academic Foundation`S Bulletin On Banking And Finance Volume -30

On 19 January 2009 Graham Badman - former Director of Children's Services in Kent - was asked to carry out a review of elective home education in England. The terms of reference for the review emphasised the Government's recognition of parents' well established right to educate their children at home. They also set out the pre-eminent right of the child to receive a suitable education in a safe environment. While around 20,000 children are already registered, the actual number being home educated is unknown and could be more than double this number. The key recommendations include: (1) that local authorities should provide more support to home educating families, eg. through helping provide access to the national examination system, sports facilities, libraries and music tuition; (2) a compulsory annual registration scheme, in which all parents who plan to home educate have to inform their local authority; While around 20,000 children are already registered, the actual number being home educated is unknown and could be more than double this number; (3) at the time of registration, parents being asked to submit a statement of their intended approach to the child's education including what they aim to achieve over the following 12 months; (4) giving properly trained local authority officials the right of access to the home, following a minimum two week notification to the parents, allowing them to check that the child is making progress against their learning statement; they will also have the right to speak to the child, to ensure they are safe and well after which a written report must then be produced and shared with the parents and child; and (4) that local authorities can refuse registration to home educate if there is clear evidence of safeguarding concerns.
