Morocco 2040: Emerging by Investing in Intangible Capital documents the major economic and social strides made by Morocco over the past 15 years and analyzes the economic conditions for accelerating the pace of economic catch-up by 2040. A virtuous yet realistic scenario suggests that with higher productivity gains Morocco could double its current pace of convergence with Southern European countries. In one generation, Morocco's standard of living could reach about 45 percent of that of Spain, its immediate Northern neighbor, compared to the current rate of 22 percent. To lay out the possible pathways for Morocco to become the first North African country to attain upper middle income status, the Book then investigates the policies that could bring about such a virtuous scenario of accelerated economic convergence. It shows that sustaining higher productivity gains for 25 years would require greater efforts at building Morocco's institutional, human and social capital—what is also known as intangible capital. Accumulating such intangible capital necessarily take a number of different forms and the Book proposes a four-pronged approach. First, by strengthening Morocco's market institutions for a more efficient allocation of capital and labor and international integration. Second, by strengthening Morocco's public institutions to strengthen the rule of law and justice, modernize the public administration, and improve the quality of public service delivery. Third, by strengthening Morocco's human capital, especially education, health and the development of early childhood. And fourth, by strengthening Morocco's social capital through greater gender parity and increased interpersonal trust and civism in society. By placing more of a priority on its intangible capital, Morocco would be advancing a social contract based on the promotion of a more open society. It would be taking a route that is partly new, but which is also the logical outcome of many economic and social diagnoses and pressing calls for change.

Drug overdose, driven largely by overdose related to the use of opioids, is now the leading cause of unintentional injury death in the United States. The ongoing opioid crisis lies at the intersection of two public health challenges: reducing the burden of suffering from pain and containing the rising toll of the harms that can arise from the use of opioid medications. Chronic pain and opioid use disorder both represent complex human conditions affecting millions of Americans and causing untold disability and loss of function. In the context of the growing opioid problem, the U.S. Food and Drug Administration (FDA) launched an Opioids Action Plan in

early 2016. As part of this plan, the FDA asked the National Academies of Sciences, Engineering, and Medicine to convene a committee to update the state of the science on pain research, care, and education and to identify actions the FDA and others can take to respond to the opioid epidemic, with a particular focus on informing FDA's development of a formal method for incorporating individual and societal considerations into its risk-benefit framework for opioid approval and monitoring.

## **Ethical Obligations and Decision Making in Accounting**

Being deployed to a war zone can result in numerous adverse psychological health conditions. It is well documented in the literature that there are high rates of psychological disorders among military personnel serving in Operation Enduring Freedom in Afghanistan and Operation Iraqi Freedom in Iraq as well as among the service members' families. For service members' families, the degree of hardship and negative consequences rises with the amount of the service members' exposure to traumatic or life-altering experiences. Adult and child members of the families of service members who experience wartime deployments have been found to be at increased risk for symptoms of psychological disorders and to be more likely to use mental health services. In an effort to provide early recognition and early intervention that meet the psychological health needs of service members and their families, DOD currently screens for many of these conditions at numerous points during the military life cycle, and it is implementing structural interventions that support the improved integration of military line personnel, non-medical caregivers, and clinicians, such as RESPECT-Mil (Re-engineering Systems of Primary Care Treatment in the Military), embedded mental health providers, and the Patient-Centered Medical Home. Preventing Psychological Disorders in Service Members and Their Families evaluates risk and protective factors in military and family populations and suggests that prevention strategies are needed at multiple levels - individual, interpersonal, institutional, community, and societal - in order to address the influence that these factors have on psychological health. This report reviews and critiques reintegration programs and prevention strategies for PTSD, depression, recovery support, and prevention of substance abuse, suicide, and interpersonal violence.

## **School, Family, and Community Partnerships**

This book builds on existing work exploring succession, disturbance ecology, and the interface between geophysical and biological systems in the aftermath of the 1980 eruptions of Mount St. Helens. The eruption was dramatic both in the spatial extent of impacts and the range of volcanic disturbance types and intensities. Complex geophysical forces created unparalleled opportunities to study initial ecological responses and long-term succession processes that occur in response to a major contemporary eruption across a great diversity of ecosystems—lowland to alpine forests, meadows, lakes, streams, and rivers. These factors make Mount St. Helens an extremely rich environment for learning about the ecology of volcanic areas and, more generally, about ecosystem response to major disturbance of many types, including land management. Lessons about ecological recovery at Mount St. Helens are shaping thought about succession, disturbance ecology,

ecosystem management, and landscape ecology. In the first five years after the eruption several syntheses documented the numerous, intensive studies of ecological recovery. The 2005 volume "Ecological Responses to the 1980 Eruption of Mount St. Helens" (Springer Publishing) was the first ecological synthesis since 1987 of the scores of ecological studies underway in the area. More than half of the world's published studies on plant and animal responses to volcanic eruptions have taken place at Mount St. Helens. The 25-year synthesis, which generally included investigations (i.e., data) from 1980-2000, made it possible to more thoroughly analyze initial stages of ecological responses and to test the validity of early interpretations and the duration of early phenomena. And 35 years after the eruption, it is time for many of the scientists working in the first three-decade, post-eruption period to pass the science baton to the next generation of scientists to work at Mount St. Helens, and a synthesis at this time of transfer of responsibility to a younger cohort of scientists will be an enormous asset to the continuation of work at the volcano.
